Break down can start no sooner than 3:00 pm and must be completed by 4:30 PM. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces. *Before leaving, be sure your area is clean and trash-free.
2. Staffing: Exhibitor tables/ booths must be manned at all times and intact until show closes at 3 p.m. Lucky Find Market is not responsible for merchandise or display materials.
3. Exhibitor Items: Items for sale at the Exhibitor's booth must be listed on this application. Lucky Find Market reserves the right to have items removed that are considered not appropriate for the Market.
4. Exhibitor Responsibility: Exhibitor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. The Lucky Find Market expressly disclaims any responsibility for same. Exhibitors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation.
